Guidelines and tariffs for aviation fuels at Sion Airport 2024

1. Validity

- From 01.09.2024 - 31.12.2024;
- The accounting period for fuel quantities runs from 1 September 2024 to 31 December 2024.

2. Orientation

- From 01.09.24, a new pricing policy for the sale of fuel will be applied uniformly to all airport customers;
- The definition of "based users" no longer applies to the new pricing policy.

3. Conditions of access to fuel discounts

All Sion airport customers can benefit from fuel discounts by opening an account with the airport and signing an appropriate agreement. A deposit may be required. The granting of the annual rebate paid in February 2025 is subject to the following conditions:

- At 28.02.2025, the account concerned must have no unpaid fuel invoices for the year 2024 ;
- In the event of a disputed invoice open on 28.02.2025, an agreement will be signed between the customer and Sion Airport to postpone payment of the discount until such time as the law is known;
- There must not have been any legal proceedings initiated by the Aéroport/Ville de Sion against the fuel account in question during the last twelve months.
- The quantity of fuel eligible for the rebate will begin to be taken into account in accordance with the terms of the agreement - Appendix 1 of this document - duly signed, but no later than 01.09.2024;
- The fuel account holder must inform Sion airport without delay of any change in its structure or operations that may affect its fuel account.

4. Fuel account

- A fuel account may include several companies, but only one beneficiary must be designated;
- Quantities booked to a fuel account can be paid as follows
 - Directly by credit card
 - In cash ;
 - By individual invoice to the beneficiary of the account ;
 - By total monthly invoice to the account beneficiary.

These terms and conditions must be set out in the agreement;

- Deliveries invoiced individually or monthly must be validated by the account holder before the fuel is dispensed.

5. Transition for "based users" in favour of a discount

- Discounts per litre will no longer be granted from 01.09.2024 ;
- The old quantity discounts will be calculated for the period from 01.1.2024 to 31.08.2024;
- Customers receiving quantity discounts will receive a full statement by 31.12.2024.

6. Discount calculation

- The total quantity of litres and the total amount paid annually for all types of fuel are taken into account;
- Quantities delivered on "fuel release" accounts do not qualify for rebates;
- Discounts cannot be combined.

7. 2024 discount table from 01.09.24 to 31.12.24

- The percentage discount granted according to the quantity of fuel booked to the account will be applied to the pre-tax turnover (less VAT and/or mineral oil tax) of the same account.

8. Incentive rebates for biofuel (SAF)

- The airport management can issue special discounts valid for one week for SAF.

9. Additional provisions

- Sion Airport reserves the right to amend these guidelines in the event of changes in regulations or market conditions. Customers will be informed of any changes at least 30 days before they take effect.
